MINUTES OF THE RIO VERDE FIRE DISTRICT BOARD OF DIRECTORS SPECIAL SESSION

August 25, 2022

I. CALL TO ORDER

The Thursday, August 25, 2022, Special Session of the Board of Directors was called to order by Chairperson George Kattermann at 2:00 p.m. in the Rio Verde Fire District Administrative Building Board Room, Rio Verde, Arizona 85263.
